**PARENT/GUARDIAN WILL NEED  
THE FOLLOWING ITEMS:**

**Proof of Residency** (one of the following)

- Mortgage/lease statement
- Public utility bill such as water, electric, gas (no phone or cable)
- Initial Shared Housing Affidavit (available at any school or via HCS website)

**Photo Identification of Parent or Guardian**

**Child's State Issued Birth Certificate**

**Income Verification** (one of the following)

Qualifying incomes must be at or below 200% of the Federal Poverty Guidelines. **See back of flyer for guidelines.**

- Income tax return (current year)
- Military residents must provide current Leave & Earnings Statement (LES)
- W-2 form (current year)
- Two Pay Statements (2 most current)
- All other sources of income

The child must be 4 years old on or before September 30, 2024.

• Parent/legal guardian must be present at appointment.

• Child's Physical and Immunization Records are required to participate. Both forms should be given to the school once your child is accepted.

• Please call 757-727-2419 if your child has a current IEP or if you have questions regarding the Special Education process.

• Current Head Start enrollees do not qualify for this program.

Based on family income, applications may be sent to **Hampton Head Start**. Head Start will contact families accordingly.

To be eligible for the **HCS VPI program**, families must reside in Hampton and meet at least one of the following eligibility criteria:

- *Family income is at or below 200% of the federal poverty level*
- *Family is experiencing homelessness*
- *One or both of the student's parents did not graduate from high school*
- *Student qualifies for Special Education services*
- *Local eligibility criteria*
