IMPORTANT INFORMATION

COST: No cost to Hampton City Schools students.

LOCATION: Phoebus High School (PHS)
Parents must provide transportation to and from PHS.

LENGTH OF CLASS: Each session is 7 days long. Typically, the session goes from Monday through Thursday the first week. The second week, the session goes from Monday through Wednesday. Some sessions will have different days due to holidays, etc.

TIME: 4:00 p.m. to 6:00 p.m.

Eligibility for a 180-day Provisional License

1. 15 years and 6 months old (receive learner's permit).
2. Has held a learner's permit for a minimum of 9 months.
3. Has parental permission and 45 hours of guided driving practice with at least 15 hours occurring after sunset.
4. Has completed a driver education program (classroom and BTW).

The same policies found in the Students Rights & Responsibilities Handbook enforced during regular school hours shall be enforced during Behind The Wheel. Inappropriate behavior shall result in the student being sent home and rescheduled at another time.

HOW TO REGISTER

Students that have completed the classroom portion of Driver Education and have had their Learner's Permit for 3 months should fill out the bottom portion of this form and mail it to the Driver's Education office at: One Franklin Street, Suite 543, Hampton, VA 23669.
